LOCAL 246 WINS TWO-YEAR BATTLE WITH CITY ON PREVAILING RATE LAWS



After a two-year battle with the City of New York and the former Bloomberg mayoral administration, Local 246 has succeeded in putting a final stop to the Personnel Order (E.O. 88) that would have changed the protections afforded under the 220 prevailing rate laws.

Local 246 President Joe Colangelo called the battle “long and difficult.” For more than a century, skilled trades titles — including members of Local 246 — have had their wages and

benefits determined in accordance with prevailing rates as required by Section 220 of the New York State Labor Law.

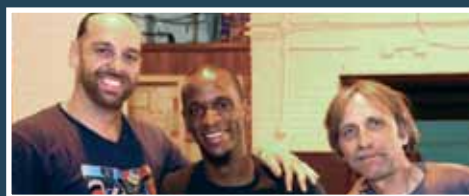
On April 11, 2012, the Bloomberg Administration adopted a resolution (E.O. 88), without notice to Local 246, reclassifying

Message from President JOSEPH A. COLANGELO



I hope everyone had a great summer and was able to spend some time with family and friends. It never ceases to amaze me how quickly the summer months fly by.

The Union was very busy these past few months, and I'm starting this message with some great news.

As you read about on the front page, the City has agreed to drop its appeal on the 220 reclassification — or E.O. 88 as most of us refer to it. Our two-year battle was supported by both the public and private sector trades, which in part helped us resolve this pending disaster that would have impacted more than 10,000 City employees.

All along, the consensus was that once the 220 salary was eliminated in the public sector, the private sector would follow since so many projects are tied to the prevailing rate. If City employees earned less, the pressure on outside contractors to meet costs would have forced them to lower their bids and in turn drive down wages of their workers, a classic domino effect. Once Mayor Bill de Blasio was in office, his Administration was updated constantly, and many discussions transpired that resulted in the City finally withdrawing its appeal.

President of the Building and Construction Trades Council of Greater New York, as well as our Attorneys Robert Burzichelli and Harry Greenberg. This was a tremendous victory for all working men and women.

During the summer, we visited many of our shops to talk about the one most important issue on everyone's minds — contracts. As you know, we had our first meeting with the City on June 17, regarding our Auto Trades contract. This is our largest contract to negotiate, and covers members in the titles of Auto Mechanic, Auto Mechanic Diesel, Auto Machinist, Machinist, and Machinist Helper. I want to thank the following Auto Trades Negotiating Committee members for their time and effort so far: Auto Mechanic Jack Minerva (San), Machinist Ed Wojcik (BOE), Auto Mechanics Stanley Pirpinias (Police), Mordechai Ziv (DOT), and Mike Faix (San), as well as Vice President James Grillo, Treasurer Raymond S. Schacor, Recording Secretary Anthony Reyes, and Trustee Wayne Esposito.

The City has not yet contacted us with a response to our demands; however, we did request all costing of the Teachers' contract settlement and Healthcare agreement, and how these would apply to our negotiations.

In July we met to begin negotiating the Motor Grader Operator and Tractor Operator contracts. We share a bargaining certificate with Local 15 of the International Union of Operating Engineers on these titles, so it is one that is jointly negotiated. At that meeting, the City told us that the costing of 220 prevailing rate contracts will take some additional time in order to finalize the values. This will, of course, affect most of our other 220 contracts. Local 246 is in the process of reviewing similar contracts with 220 titles in the private sector to evaluate if the comparisons work to our advantage.

We have requested dates for bargaining on all our other 220 titles as well — the outside NYC Auto Trades, Rubber Tire Repairer, Carriage Upholsterer, Door Stop and Door Check Maintainers, Letter/Sign Painter and Sheet Metal Workers. The Auto Service

Workers contract is a career and salary contract and is directly impacted by the Citywide settlement. This contract includes the titles of Auto Service Worker Level I and II, Auto Body Worker, Oil Burner Specialist, and Marine Maintenance I & II.

With each contract, we will select members from that title to participate at bargaining so all titles can express their concerns and demands for themselves. The contract talks are always difficult and the Executive Board is committed to doing our very best to achieve the goal of settling the contract. We have waited years to make it this far and are hopeful that with the new de Blasio Administration, actual "negotiating" takes place. From what we have seen so far, we are remaining optimistic and are hopeful that all our contracts will be resolved very soon.

On a different note, Welfare Fund trustees met in June and are in the process of evaluating improvements to the dental program. Target date for these changes is January 1, 2015. Once everything has been finalized, plan participants will receive letters detailing the improvements. The prescription plan took steps to protect our funds and made additional changes to the benefits. Letters are being sent out explaining those new guidelines.

The annual Central Labor Council Labor Day Parade is scheduled for Saturday, September 6. Local 246 will be marching in unity and solidarity with dozens of other unions from the City and beyond. Please join us as we gather on West 46th Street between 5th and 6th avenues. We are striving for at least as large a turnout as last year. Come with your friends, your family, your coworkers, and of course your antique cars, trucks, and motorcycles.

I look forward to seeing you at the September General Membership meeting, the first after our two-month summer hiatus, so I can give you all further updates on issues impacting our Union.

COBRA APPLICATIONS — If you are no longer in active pay status you may not be eligible for health benefits and/or welfare benefits. You must purchase these benefits directly through the COBRA program for welfare benefits you should contact the union office. For health benefits you should contact the agency benefits coordinator. You must enroll within 60 days from the qualifying event.

DEPARTMENT OF SANITATION RETIREMENT & REUNION DINNER

URGENT CALL TO UPDATE YOUR BENEFICIARY CARD

— Members when was the last time you thought about, who's your Beneficiary? Over the years your beneficiary might have changed. It's important to you and for our office to have the correct information for each member on their beneficiary card. Please contact the Fund office at (212) 233-0616 and request that a new beneficiary card be sent to you. Once you received the card, fill it out completely and accurately and send it back to our office immediately before you forget.

ONLY MEDICARE-ELIGIBLE RETIREES ENROLLED IN APPROVED HMOs

— NYC Local 246 will prepare the first half of 2014's reimbursement payments for those Medicare eligible retirees currently enrolled and/or who have opted to purchase their drug rider through deductions in their pension checks. In order to receive reimbursement from the Retirees Welfare Fund, eligible retirees must forward to the Union Office copies of their pension stubs for the period of January 1-June 30, 2014.

COLLEGE LETTERS DUE NOW FOR RETIREE

— Retiree members with dependents ages 19 to 23, who are attending college full time, must submit proof each semester – fall and spring. A

letter that is signed dated and bears the seal of the College Registrar, stating that the dependent is a full time, matriculated student is required as proof of eligibility for the prescription Welfare Benefit. Prescription claims for dependents that letters have expired will not be honored. They will be terminated.

the Union's titles from Labor Law §220 prevailing rate employees to graded titles. This reclassification plan altered wages and supplements and leave regulations.

"The change to benefits alone would have amounted to more than \$6,000 per new hire," Colangelo said. "This massive reclassification overhauled a system that had been in place for more than a 100 years, whereby prevailing rates are set by the New York City Comptroller. The Bloomberg Administration tried to sneak this through under the cover of night in an attempt to undermine the unions. It didn't work."

Local 246 sought and obtained a temporary restraining order from the New York City Supreme Court. The same court later granted Local 246's petition annulling the City's reclassification plan and concluding that it was arbitrary and capricious because it violated New York State Civil Service Law §20 and New York State Labor Law §220(8-d). The City then appealed the Trial Court's decision, but the Appellate Division unanimously affirmed the lower court's decision. In late 2013 the Bloomberg Administration pressed on, appealing to the State's highest court, the Court of Appeals, and the matter was scheduled for oral argument in September 2014.

Colangelo said Local 246 extends sincere thanks to the Union's Attorneys, Robert Burzichelli and Harry Greenberg, for their great work and collaboration with counsel from the other impacted unions. Thanks also goes to Harry Nespoli, Chairman of the MLC; Vincent Alvarez, President of the CLC; and Gary La Barbera, President of the Building and Construction Trades Council of Greater New York.

"Everyone came together to make this possible," Colangelo said. "It was a team effort fighting the City and we won."

Through fruitful discussions with Mayor Bill de Blasio's office and Corporation Counsel, all parties were able to agree to withdraw the pending appeal before the State's highest court. As a result, the Appellate Division's decision in favor of Local 246 stands, and the reclassification continues to be invalid.

"This not only is a great victory for our members, but a victory that will live on through the lives of future members and of all the prevailing wage employees who work for the City of New York," Colangelo said.
